At the Regular Meeting of the Board of Supervisors of Bath County, Virginia, Lynn Ellen Black, Chairperson; Roy W. Burns, Vice-Chairman; H. Lee Fry, John A. Lockridge, and Ronald R. Shifflett, Supervisors; Julian Harf, County Attorney; and Michael J. Bender, Jr., County Administrator.

Chairperson Black called the meeting to order at 6 p.m.

County Administrator Bender called the roll.

Present: Chairperson Black, Supervisor Burns, Supervisor Fry, Supervisor Lockridge, and Supervisor Shifflett.

Absent: none

Chairperson Black led the Pledge of Allegiance. A moment of silence was observed.

Chairperson Black asked the Board if they wished to approve or amend the agenda.

Supervisor Lockridge made the motion to approve the agenda as presented and to reinstate item 6 to set a public hearing to solicit input to revise Bath County Code Chapter 16 Solid Waste, that had been removed from the agenda. Supervisor Shifflett seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Chairperson Black asked the Board if they wished to approve or amend the minutes from the February 8, 2024, Board of Supervisors budget work session, February 13, 2024, Board of Supervisors monthly meeting, February 20, 2024, budget work session, and the February 21, 2024, joint work session with Bath County School Board.

Supervisor Burns made the motion to approve the minutes of the February 8, 2024, Board of Supervisors budget work session, February 13, 2024, Board of Supervisors monthly meeting, February 20, 2024, budget work session, and the February 21, 2024, joint work session with Bath County School Board. Supervisor Lockridge seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Public Comment

Carl Chestnut, Cedar Creek District apologized for his comments at the February Board meeting. Mr. Chestnut recommended the Economic Development Authority be changed to an Industrial Development Authority. Mr. Chestnut asked the Board to repair lighting in front of the Courthouse.

Rocky Phillips, Cedar Creek District concurred with Mr. Chestnut's comments.

Richard Brooks, Warm Springs District highlighted risks associated with Bath County becoming a constitutional county.

Zach Woodzell, Jack's Trash Service Director of Operations, announced that Jack's Trash is currently entering Spring clean-up mode, new bottoms have been ordered for the solid waste cans, and cans will be painted resulting in some sites not operating at full capacity for a few days. Mr. Woodzell stated he planned to get the word out as much as possible using social media.

Jay Trinca, Warm Springs District stated, what went on at the last Board of Supervisors meeting was hatred. Mr. Trinca added that he would like the public record to show that he was not out of order at the February Board meeting, however, he was unfairly and rudely accosted by Liz Knapp. Mr. Trinca stated he was exercising his first amendment right to speak. Mr. Trinca clarified the February minutes incorrectly stated that he opposed people coming to Bath County. Mr. Trinca explained what he is opposed to is illegal immigrants coming to Bath County.

Jon Trees, Warm Springs District thanked Jack's Trash Service for keeping the Mountain Grove convenience site clean. Mr. Trees urged the Board to consider categorical funding for the FY 2024-2025 budget.

Wally Robertson, Cedar Creek District disagreed with the Board adding a public hearing on solid waste to the agenda.

Alan Seacord, Williamsville District stated he would address questions raised by Richard Brooks at an upcoming town hall meeting. Mr. Seacord stated Jeff Cleek reminds us that our rights come from God and natural law. Mr. Seacord ended with a prayer.

Board Chair Report

Chairperson Black recognized the Circuit Court Clerk's Office for their efforts to acquire a \$24,620 grant. Chairperson Black congratulated the Boys A-League Basketball team for their success in the areawide tournament. Chairperson Black stated the Board and County Administration continue to work on the FY 2024-2025 budget.

Board Comment

Supervisor Fry asked everyone to keep the families of the five people that perished in the plane crash at Ingalls Field in their thoughts and prayers.

Supervisor Burns stated the Board is still working on the budget and the Board will not take action on EDA appointments at tonight's meeting. Supervisor Burns thanked Jack's Trash Service for making improvements to the solid waste process. Supervisor Burns agreed to consider categorical funding during the budget process. Supervisor Burns recognized first responders for the difficult work they do during emergency situations such the recent plane crash at Ingalls Field.

Supervisor Lockridge informed the Board that Kevin Kyle, USFS James River and Warm Springs District Ranger would attend the April Board of Supervisors meeting to discuss forest service road closures and Lake Moomaw.

Chairperson Black expressed condolences to the family of those who perished in the plane crash at Ingalls Field on Sunday, March 10, 2024. Chairperson Black stated that Susan Hammond, VDOT Residency Administrator would attend a Board meeting in the near future to provide an update on Main Street lighting.

Set public hearing to solicit input to revise Bath County Code Chapter 16, Solid Waste

Supervisor Burns made the motion to set a public hearing for the April 9, 2024, Board of Supervisors meeting at 6 p.m. or soon thereafter, to solicit input to revise Bath County Code Chapter 16, Solid Waste. Supervisor Fry seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Capital Improvement Plan for FY's 2025-2029

Sherry Ryder, County Planner presented the Capital Improvement Plan for FY's 2025-2029. Mrs. Ryder informed the Board that the Planning Commission met on Monday, February 26, 2024, to hear requests from departments. The Planning Commission scored the requests based on criteria implemented in previous years. Requests were scored from Group A: urgent, high priority that should be funded, if possible, to Group C: projects to be considered if funding becomes available; may be deferred to a subsequent year. Projects recommended by the Planning Commission to the Board of Supervisors for consideration are as follows.

Group A: Hot Springs Rescue Squad - replace a rescue squad \$425,000

Group A: Bath County Public Schools – school entrance security all three schools \$150,000

Group C: Bath County Public Service Authority - Rt. 39 East well project \$203,525

Supervisor Burns made the motion to accept the Capital Improvement Plan for FY's 2025-2029 as recommended by the Planning Commission, for consideration in the budget development process. Supervisor Lockridge seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Appointments to Boards and Commissions

Supervisor Lockridge made the motion to appoint Daniel Plecker to the Bath County Service Authority representing the Millboro District for a term ending March 24, 2028. Supervisor Shifflett seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Public Comment

Bugs Phillips, Warm Springs District inquired about the capital improvement request for Hot Springs Rescue Squad.

Bruce McWilliams, EDA Chairman asked the Board to consider meeting to discuss exactly what the Board's concerns are with the EDA. Mr. McWilliams stated that the EDA is the only authority in the County that does not cost the County money. Mr. McWilliams asked the Board if they were also concerned about oversight of the Bath County Airport Authority and Bath County Service Authority.

Carl Chestnut, Cedar Creek District contested Mr. McWilliams comments, stating that the County pays a stipend of \$75 per month to each of the seven (7) EDA members for their attendance at monthly EDA meetings.

Jay Trinca, Warm Springs District questioned why the EDA does not have formal by-laws. Mr. Trinca commended Alan Seacord for starting the conversation regarding Bath County becoming a constitutional county. Mr. Trinca recommended the Board of Supervisors educate themselves on the U.S. Constitution and the Bill of Rights.

Kes Phillips, Cedar Creek District asked if the County had plans to fill the Director of Parks and Recreation position.

Jack Lindsay, Cedar Creek District reinforced the need to replace a rescue squad for Hot Springs Rescue Squad.

Wally Robertson, Cedar Creek District thanked the Board for answering questions from citizens.

Jeff Cleek, Warm Springs District commented on the budget for school operations and urged the School Board to use the one million dollars in school construction funds to pay for current projects.

Jon Trees, Warm Springs District spoke in favor of categorical funding for all departments receiving county funds.

Stephen Hiner, Warm Springs District thanked area rescue squads for answering calls in Mountain Grove. Mr. Hiner who serves as the vice-chairman of the EDA stated EDA meetings are open to the public and he will gladly give up the \$75 stipend for attending meetings if citizens have an issue with the pay.

Closed Session

Supervisor Lockridge made the motion to convene the Board of Supervisors in closed meeting pursuant to Virginia Code §2.2-3711(A)(8) to obtain legal advice concerning EDA oversight and the proposal to become a Constitutional County. Supervisor Burns seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Supervisors Lockridge made the motion to end the closed session of the Board of Supervisors and reconvene the regular meeting. Supervisor Fry seconded the motion, which was

adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Supervisor Lockridge moved pursuant to Virginia Code §2.2-3712(D) that the Board of Supervisors certify that, to the best of each member's knowledge, only public business matters lawfully exempted from open meeting requirements of the Virginia Freedom of Information Act and only such public business matters were identified in the motion convening the closed meeting were heard, discussed, or considered during the closed meeting. Supervisor Shifflett seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

There was no action from the closed session.

Board review of department budgets

County Administrator Bender gave an overview of the budgets for County Administration and Parks and Recreation.

Board members discussed advertising the Parks and Recreation Director position as well as restructuring the department.

Meeting Adjournment

Supervisor Burns made the motion to adjourn the meeting. Supervisor Lockridge seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Chairperson Black adjourned the meeting.

At the work session of the Board of Supervisors of Bath County, Virginia, Lynn Ellen Black, Chairperson; Roy W. Burns, Vice-Chairman; H. Lee Fry, John A. Lockridge, and Ronald R. Shifflett, Supervisors; and Michael J. Bender, Jr., County Administrator.

Chairperson Black called the meeting to order at 9 a.m. The purpose of the meeting is to discuss individual department budgets to gain better understanding of department budget requests.

Chairperson Black introduced Pam Webb, Bath County Treasurer.

Ms. Webb thanked the Board for allowing her time to present the Treasurer's FY 2025 budget request. Ms. Webb asked for a 9.3% salary increase for her staff. Ms. Webb explained her Deputy Treasurers have met the criteria for certification through the Weldon Cooper Center for Public Service. Ms. Webb explained payment options offered to taxpayers. Ms. Webb explained safety and DMV compliance updates she would like to make in her office over the next fiscal year.

Chairperson Black introduced Angel Grimm, Commissioner of the Revenue.

Ms. Grimm requested a 12.3% salary increase for her staff. Ms. Grimm stated both Deputy Commissioners in her office have completed the master certification program. Ms. Grimm asked for equality in salaries across the school system and county departments. Ms. Grimm compared her deputies to the Director of Maintenance at Bath County High School whose salary is considerably more than her deputies'. Ms. Grimm explained the increases in her FY 2025 budget and the workload increases taken on by her office over the past several years.

Chairperson Black introduced Theresa Frady, Buildings and Grounds Supervisor.

Ms. Frady provided an overview of the FY 2025 budget request for the Buildings and Grounds Department. Ms. Frady explained that her maintenance line item covers the Courthouse, E911 building, Sheriff's Office, Library, Health Department, and the HVAC system at the Animal Shelter. Ms. Frady stated the Courthouse and other County buildings have aging electrical and HVAC systems. Ms. Frady went over increases to her budget. Paving and sidewalk replacement make-up the largest increase.

Chairperson Black introduced Teresa Phillips, E911 Administrator.

Ms. Phillips explained the rising costs of maintenance agreements to operate the 911 center. Ms. Phillips went over line items within the budget and answered questions related to the increases in line items.

Chairperson Black introduced Annette Loan, Clerk of the Circuit Court.

Ms. Loan explained that the Circuit Court operates under two separate budgets. The Circuit Court budget funds operations for the court, and the Clerk of the Circuit Court funds salaries, benefits, and materials needed to run the office. Ms. Loan asked the Board to fund a part-time position in her office that has not been funded for the past two years. Ms. Loan explained grants that she applies for to help with expenses. Ms. Loan explained capital outlay requests included in her budget.

Chairperson Black introduced Sharrie Woodzell, Animal Shelter Manager.

Ms. Woodzell provided an overview of Animal Shelter expenditures. Ms. Woodzell discussed the challenges of accessing the shelter due to the steep entrance. Supervisor Burns offered to look at an alternate location for the Board to consider in the future.

Chairperson Black introduced Sheriff Plecker and Major Byran, Sheriff's Office and Animal Control.

Major Bryan explained the Animal Control Budget which consists of supplies and materials to fund animal control, and salary, and benefits, for one officer. Sheriff Plecker stated there are currently two fully accredited animal control officers; a third officer should be accredited later this year.

Sheriff Plecker and Major Bryan gave a brief overview of the Sheriff's office budget including salaries and benefits for staff, technology, vehicle and building maintenance, training, and other miscellaneous supplies.

Board members requested the Animal Control budget be incorporated into the Sheriff's office budget.

Chairperson Black introduced Andy Seabolt, Emergency Services Coordinator.

Mr. Seabolt provided information on pass-through accounts including VA Department of Fire Programs \$30,000, VDEM LEMPG \$7,500, and Four for Life Expenses \$5,900. Mr. Seabolt touched briefly on the radio grant for Bath and Highland Counties.

Chairperson Black introduced Sherry Ryder and Andy Seabolt, Building Planning and Zoning.

Ms. Ryder and Mr. Seabolt gave an overview of services provided by Building, Planning and Zoning, including flood plain management, GIS, mapping and addressing, building permits and inspections, and updates to the Comprehensive Plan and Land Use Regulations, due every five years.

Chairperson Black introduced Donna Weaver, General Registrar and Director of Elections.

Ms. Weaver explained her requests for compensation for election workers and part-time help. The General Registrar's office has one full-time employee (Ms. Weaver) and one part-time employee who works less than 30 hours per week. Ms. Weaver requested funding for a new copier and a slight increase in general maintenance. Ms. Weaver urged the Board to begin setting aside funds to replace voting equipment.

Adjournment

Supervisor Burns made the motion to adjourn the work session. Supervisor Shifflett seconded the motion, which was adopted 5 in favor, 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Chairperson Black adjourned the meeting.

Ordered that this Board is now adjourned.

Chairperson Lynn Ellen Black called the Bath County Board of Supervisors to order.

Chairman Henry Budzinski called the Highland County Board of Supervisors to order.

County Administrator Bender thanked the Boards for attending to discuss the joint land mobile radio project. Mr. Bender introduced Highland County Sheriff Bob Kelly and Bath County Sheriff's Lieutenant Jeff Grimm.

Sheriff Kelly and Lieutenant Grimm provided an overview of the land mobile radio project and funding sources. Lieutenant Grimm and Sheriff Kelly presented communication challenges both counties deal with daily. Sheriff Kelly and Lieutenant Grimm shared personal experiences related to poor communication systems. Lieutenant Grimm gave a summary of the joint grant received by Bath and Highland Counties to upgrade radio communications. Lieutenant Grimm explained how the system would improve coverage and allow enhanced communications with surrounding localities. The system is estimated to cost in the \$8 million dollar range, although the exact cost cannot be determined until the project is complete, according to County Administrator Bender. The project will be broken down in stages with the localities applying for additional grants to help fund the project.

Andy Seabolt, Emergency Management Coordinator stated Pocahontas and Pendleton Counties in West Virginia have expressed interest in joining the project which will allow the project management team to apply for grants that encompasses multiple states.

County Administrator Bender explained the request for proposals (RFP) process which will be presented to each Board of Supervisors at their regular meeting in April. County Administrator Bender stated that he and Interim County Administrator Jerri Botkin would work to develop a resolution seeking Board approval to actively seek out technical expertise and grant opportunities to aid in the development and funding of the LMR project.

After comments and questions from the Board of Supervisors and members of the public the meeting was adjourned.

Supervisor Burns made the motion to adjourn the work session. Supervisor Fry seconded the motion, which was adopted 4 in favor, 0 against, 1 absent with Supervisors Black, Burns, Fry, and Shifflett voting aye. Supervisor Lockridge was absent from the work session.

Chairperson Black adjourned the work session.

Ordered that this Board is now adjourned.

At the budget work session of the Board of Supervisors of Bath County, Virginia, Lynn Ellen Black, Chairperson; Roy W. Burns, Vice-Chairman; H. Lee Fry, John A. Lockridge, and Ronald R. Shifflett, Supervisors; and Michael J. Bender, Jr., County Administrator.

Chairperson Black called the meeting to order at 6:00 p.m.

County Administrator Bender provided an overview of changes from previous drafts of the FY 2025 budget. The Public Service Corporation tax rate was reduced to 80% based on information provided by The Commissioner of the Revenue that she received from the State Corporation Commission. Salary increases were reduced from 4% to 3%. Expenditures for Bath County Public Schools were reduced by \$207,559 by removing one teaching position and not funding a school bus replacement. Capital Improvement Plan requests for an ambulance replacement for Hot Springs Rescue Squad \$450,000, and security vestibules for Bath County Schools \$130,000 were removed from the budget. Paving and sidewalk improvements at the Courthouse were increased to \$300,000. Municipal Solid Waste Enterprise Fund has been created to account for funding streams tied to potential changes to the municipal solid waste code.

Board members discussed additional cuts to the school budget and the possibility of categorically funding the school system. Supervisor Burns felt the schools should not be singled out, and if the Board implemented categorical funding it should include any department or agency receiving county funds. Supervisor Burns questioned how the county would function in ten (10) to fifteen (15) years if revenues continued to decline while expenditures increased.

County Administrator Bender asked the Board to set a work session for April 23, 2024, at 6 p.m., to make their final modifications before the budget public hearing scheduled for May 14, 2024, to allow for advertising of the budget.

Supervisor Burns made the motion to adjourn the meeting. Supervisor Lockridge seconded the motion, which was adopted 5 in favor, and 0 against, with Supervisors Black, Burns, Fry, Lockridge, and Shifflett voting aye.

Chairperson Black adjourned the work session.

Sec. 16-1. Purpose.

The Solid Waste Ordinance which constitutes this Chapter of the Bath County Code was established for the purpose of protecting, promoting, and preserving an environment that is conducive to public health and welfare and preventing the creation of nuisances and the depletion of our natural resources, and to maintain such levels of air quality and water quality as will protect human health, welfare, and safety; and to the greatest degree practicable, prevent injury to plant and animal life and property, and nurture the comfort of the people and their enjoyment of life and property; and to encourage the social and economic development of Bath County and facilitate enjoyment of its attractions.

ARTICLE II. DEFINITIONS

Sec. 16-2. Definitions.

For purposes of this Chapter, the following terms shall have the meanings specified below:

Animal Carcasses means any animal, bird, or fish that has died naturally or has been accidentally or intentionally killed and/or those parts of any animal, bird, or fish that results from its death.

Animal Waste means waste products from any animal to include cattle, sheep, poultry, and those animals existing in the wild.

Business means any corporation, partnership, association, sole proprietorship, municipal corporation or governmental entity (other than Bath County or the Bath County Public Schools) or other legal entity exclusive of individuals and charitable organizations (i.e., those organizations which have obtained an exemption from the federal income tax pursuant to Section 501(a) or (c) of the Internal Revenue Code.)

Clean Fill means dirt, brick, concrete or asphalt free of any paint or contaminants.

Commercial Waste means all solid waste generated by establishments engaged in business operation. This category includes, but is not limited to, solid waste resulting from the operation of stores, markets, office buildings, restaurants and shopping centers.

Construction Debris means solid waste produced or generated during construction, remodeling, or repair of pavements, houses, commercial buildings, and other structures. Construction debris includes, but is not limited to lumber, wire, sheet rock, broken brick, shingles, glass, pipes, concrete, paving materials, flooring (tile, fabric, wood, or other) and metal and plastics if the metal or plastics are a part of the materials of construction or empty containers for such materials. Paints, coatings, solvents, asbestos, any liquid compressed gases or semiliquids and garbage are not construction debris.

Designated Permitted Landfill means Peter's Mountain Landfill owned and operated by the City of Covington, Virginia, or any other permitted solid waste facility operating in

compliance with the laws and regulations of the Commonwealth of Virginia, or other states, and the United States, as may be approved by the Board of Supervisors.

Disposal or Tipping Fee means the per pound (or per ton) monetary fee assessed for solid waste received at the transfer station or Designated Permitted Landfill that has either been brought across the weigh scales or has a fee allotted to the material.

Garbage means all decayable waste including discarded materials composed of vegetable or other organic matter, animal offal and recognizable industrial by-products but excluding sewage and human waste.

Hazardous Waste means a solid waste or combination of solid waste which, because of its quantity, concentration or physical, chemical or infectious characteristics, may (1) cause or significantly contribute to an increase in mortality or an increase in serious irreversible or incapacitating illness; or (2) pose a substantial present or potential hazard to human health or the environment when improperly treated, stored, transported, disposed of, or otherwise managed. Hazardous waste includes, but is not limited to such items as petroleum wastes, paints, plastics, explosives, acids, caustics, chemicals, poisons, drugs, radioactive materials, pathogenic wastes from hospitals, sanitariums, nursing homes, clinics, and veterinary hospitals, waste from slaughter houses, poultry processing plants, and the like, or any other waste deemed hazardous by the Resource Conservation and Recovery Act and/or by the Virginia Department of Environmental Quality's Hazardous Waste Management Regulations.

Household Waste means any waste material including garbage, trash, and refuse, derived from households.

Industrial Waste means any solid waste generated by manufacturing or industrial process that is not a regulated hazardous waste. Such waste may include, but is not limited to, waste resulting from the following manufacturing processes: Electric power generation; fertilizer/agricultural chemicals; food and related products/by-products; inorganic chemicals; iron and steel manufacturing; leather and leather products; nonferrous metals manufacturing/foundries; organic chemicals; plastics and resins manufacturing; pulp and paper industry; rubber and miscellaneous plastic products; stone, glass, clay, and concrete products; textile manufacturing; transportation equipment, and water treatment. This term does not include mining waste or oil and gas waste.

Infectious Waste means any solid wastes defined to be infectious by the Infectious Waste Management Regulations (VR 672-40-01) as promulgated by the Department of Environmental Quality. To the extent not inconsistent with the Regulations promulgated by the Department of Environmental Quality, Infectious Waste shall mean any waste that is considered to be capable of producing an infectious disease if it has been or may have been contaminated by an organism that may be pathogenic to humans, if such organism is not routinely and freely available to the community and if such organism has a significant probability of being present in significant quantities and with significant virulence to transmit disease, including but not limited to quarantine waste; discarded cultures, stocks, specimens, and vaccines; blood and blood products; pathological waste; sharp objects including hypodermic needles, syringes, scalpel blades, pasteur pipette, and broken glass; animal carcasses; any residue or contaminated soil, water, or other

debris resulting from the cleaning of a spill of any infectious waste; and any waste contaminated or mixed with infectious waste.

Motorized Vehicles means any vehicle has an engine and is used for the transporting of people or goods. Regardless of the vehicle condition being worn-out, cast off, unused, whether self-propelled or not.

Lead acid or wet cell batteries means batteries with a primary cell having an electrolyte in the form of a liquid bath.

Litter means loose articles of solid waste or other discarded matters thrown out, scattered, or lying on roads, streets, alleys, public places or private premises.

Municipal Solid Waste means that waste which is normally composed of residential, commercial and institutional solid waste.

Open Dump means a site on which any solid waste is placed, discharged, deposited, injected, dumped, or spilled so as to create a nuisance or present a threat of a release of harmful substances into the environment or present a hazard to human health.

Person means an individual, corporation, partnership, association, a governmental body, a municipal corporation, or other legal entity.

Recyclable Materials means materials which are free of contaminants and are separated from the solid waste stream so that they may be used again as a raw material for a product which may or may not be similar to the original. Recyclable Materials shall include but are not limited to aluminum (cans and scrap), tin cans, #1 (PET) and #2 (HDPE) plastic, computer paper, newspaper, corrugated cardboard, mixed paper, and magazines, catalogs and books.

Resident means any landowner or person having a place of abode in the Bath County, Commonwealth of Virginia. The term "resident" as used herein **shall not** be construed to embrace any sole proprietorship, joint venture, corporation, partnership, firm or other legal entity having a place of business located in the County of Bath, Commonwealth of Virginia.

Small Waste Generator means any non-retail business, beauty salon, insurance, contractor, law, real estate, or banking office or any office similar to the foregoing provided that such business or office employs fewer than 5 full-time on-site employees and generates primarily paper waste.

Solid Waste means any garbage, rubbish, refuse, sludge, and other discarded material, including solid, liquid, semi-solid or contained gaseous material, resulting from residential (household), industrial, commercial, mining and agricultural operations, or community activities. Solid Waste shall include but not be limited to animal or vegetable waste, glass, metal paper, plant growth and wood, furniture, white metal goods, and all other materials which are capable of being disposed of in a County approved solid waste receiving site or at the transfer station, but does not include (i) solid or dissolved materials in domestic sewage, (ii) solid or dissolved materials in irrigation return flows or in industrial discharges which are sources subject to a

permit from the Virginia Department of Environmental Quality, (iii) source, special nuclear, or by-product material as defined by the Federal Atomic Energy Act of 1954, as amended, or (iv) Hazardous Waste.

Solid Waste Collector means a person or business that engages in the solicitation, pickup, collection, or hauling of solid waste originally belonging to someone else and charges a fee for said services.

Solid Waste Container means a metal container to be used for collection and transportation of solid waste. The metal container must have an acceptable means of closing the top during transport to prevent littering along the highways. Openings should be large enough to accommodate bulk materials from residences (mattresses, etc.) to be deposited into the metal container.

Solid Waste Generator means any person, business, or industry that generates solid waste.

Solid Waste Recycling and Receiving Site means the sites designated from time to time by the County and approved by the Virginia Department of Environmental Quality for the purpose of receiving, collecting, and preparing for transportation of the solid waste and recycling materials to a designated transfer station or disposal site.

Source Reduction means any action that reduces or eliminates the generation of waste at the source.

Source Separation means separation of solid waste from recyclables at the point of generation.

Transfer Station means a constructed facility, designated by the County and approved by the Virginia Department of Environmental Quality, where daily quantities of solid waste are received, sorted for recycling and disposal, and stored for transportation to a designated end user or disposal site.

Trash means combustible or non-combustible discarded materials and is used interchangeably with the terms "rubbish" and "refuse".

Vegetative Waste or Yard Waste means decomposable materials generated by yard and lawn care or land-clearing activities and includes, but is not limited to, leaves, grass trimmings, and woody wastes such as shrub, limb, and tree pruning's not to exceed four (4) inches in diameter, bark, and roots.

White Goods means any refrigerators, freezers, air conditioners, stoves (electric or gas), washers, dryers, hot water heaters and other similar appliances.

Cross reference-Definitions and rules of construction generally, § 1-2.

ARTICLE III. TRANSFER STATION

Sec. 16-3. County to operate transfer station and document solid waste and recyclable materials.

The County will be responsible for operating a Transfer Station for the collection and compaction of all solid waste and recyclable materials. Monthly weight documentation of all solid waste and recyclable materials shall be recorded by the County.

Sec. 16-4. Materials to be accepted at transfer station.

Materials to be accepted at the Transfer Station during designated hours of operation will include:

- (a) Household Solid Waste
- (b) Vegetative Waste
- (c) Yard Waste
- (d) Tires
- (e) White Goods
- (f) Recyclable Materials that are free of contaminants

Sec. 16-5. Materials not to be accepted at transfer station.

Materials not to be accepted at the Transfer Station will include, but are not limited to:

- (a) Hazardous waste
- (b) Infectious waste
- (c) Radioactive waste
- (d) Animal carcasses
- (e) Volatile liquids, explosives and flammable materials
- (f) Waste oil, kerosene and antifreeze
- (g) Any motorized vehicle.
- (h) Lead Acid or Wet Cell Batteries
- (i) Tree stumps
- (i) Construction Debris

Sec. 16-6. Disposal of solid waste and recyclable materials at transfer station.

- (a) Businesses and Industries: All Business Waste Generators within Bath County shall dispose of their solid waste and Construction Debris at the Designated Permitted Landfill, except for business that qualify as a small waste generator. Businesses and industries may dispose of their recyclable materials free from contaminants at the Transfer Station.
- (b) Solid Waste Collectors: All Solid Waste Collectors shall dispose of solid waste and their recyclable materials free from contaminants at the Transfer Station or Designated Permitted Landfill. Such Solid Waste Collectors shall dispose of their solid waste and recyclable

materials at least one-half hour prior to the regularly-scheduled closing time of the Transfer Station.

- (c) Residents: Bath County residents may dispose of household solid waste and recyclable materials free from contaminants at the Transfer Station or Designated Permitted Landfill.
- (d) Nonresidents: Except as otherwise provided herein, it shall be unlawful for any nonresident to place any material or solid waste at the Transfer Station or Designated Permitted Landfill.

ARTICLE IV. SOLID WASTE AND RECYCLING RECEIVING SITES

Sec. 16-7. County to operate sites.

The County will be responsible for the operation of the Solid Waste and Recycling Receiving Sites throughout the County.

Sec. 16-8. Materials to be accepted at solid waste and recycling receiving sites.

Materials accepted at the sites will include:

- (a) Household Solid Waste
- (b) Small business waste generator unless precluded by Sec. 16-9 or other sections of this Chapter 16, which solid waste is produced from operations within Bath County
- (b) Recyclable materials that are free of contaminants

Sec. 16-9. Materials not to be accepted at solid waste and recycling receiving sites.

Materials not accepted at the sites will include:

- (a) Tires
- (b) White Goods (Appliances)
- (c) Motor Vehicles
- (d) Vegetative Waste
- (e) Yard Waste
- (f) Lead Acid or Wet Cell Batteries
- (g) Animal Carcasses
- (h) Infectious Waste
- (i) Hazardous Waste
- (j) Volatile liquids, explosives and flammable materials
- (k) Waste oil, kerosene or antifreeze
- (1) Construction debris
- (m) Furniture

Sec. 16-10. Disposal of solid waste and recyclable materials at solid waste and recycling receiving sites.

- (a) Businesses and Industries: No business solid waste or industrial solid waste shall be received at any Solid Waste and Recycling Receiving Site. This provision shall not apply to businesses that qualify as Small Waste Generators. Businesses and industries may dispose of their recyclable materials free from contaminants at any Recycling Receiving Site.
- (b) Solid Waste Collectors: Solid Waste Collectors are expressly precluded from using the Solid Waste and Recycling Receiving Sites and no solid waste collected by any Solid Waste Collector shall be delivered to or disposed of at any Solid Waste and Recycling Receiving Site.
- (c) Lawful Disposal: Bath County residents may dispose of household solid waste, recyclable materials free from contaminants, and materials permitted by Sec. 16-8 above, at any Solid Waste and Recycling Receiving Site.
- (d) Nonresidents: Except as otherwise provided herein, it shall be unlawful for any nonresident to place any material or solid waste at any Solid Waste and Recycling Receiving Site.
- (e) Materials to be Placed in Containers: All solid waste and materials placed at any Solid Waste and Recycling Receiving Site shall be placed inside the containers located at such sites for receipt of waste.

Any person violating this provision shall be guilty of a Class 1 Misdemeanor.

(f) It shall be unlawful for any person knowingly to leave open any solid waste collection container at any solid waste and recycling receiving site. Any person violating this subsection shall be assessed a civil penalty in the amount of \$200 for a first offense, and \$500 for each subsequent offense.²

CHANGES TO LOCAL CODE CHAPTER 16, SOLID WASTE, ARTICLE 5, FEE STRUCTURE FOR SECTION 16-11³

Sec. 16-11. Solid waste fees.

Any person required to obtain a building/ demolition permit pursuant to applicable Ordinances in effect from time to time shall pay, in addition to any other fee required to obtain such building permit the tipping fees for all construction debris from the acquired permit and an initial fee for deposit in the General Fund for the appropriate disposition of the project's solid waste.

Trees, branches, and brush shall be separated from the construction debris and shall be taken to the transfer station and charged at the rate set forth by the Board of Supervisors and said fee (price per ton) shall be noted on the building permit application.

(a) New Construction, Renovations, Remodeling, Repairs, etc...

An owner-applicant for a single family dwelling or single proprietorship business building permit may be eligible for a reduction in the associated solid waste fee for new construction projects, as well as renovations, remodeling, and repairs, dependent on his/her yearly household income. To obtain the reduction, income eligibility must be proven by demonstration of the household income as noted in the W-2 and/or 1099 Forms for the most recent tax year.

Solid waste fees charged for these construction projects shall be 0.5 percent (0.5%) of the estimated cost of such construction project, unless the applicant is building a single-family home or single proprietorship business for personal use and provides evidence that he/she falls into an eligible household income category as listed below:

Annual Household Income	Percentage of Cost of New Construction Project Charged as Construction Solid Waste Fee	Example of Fee For \$100,000 Project
\$0-\$25,000	0.025%	\$ 25.00
\$25,001-40,000	0.05%	\$ 50.00
\$40,001-55,000	0.25%	\$ 250.00
\$55,001-Above	0.5%	\$ 500.00

Construction debris from these construction projects shall be taken to a designated site that is indicated upon issuance of the building permit. Additional tipping fees will be the responsibility of the recipient of the building/demolition permit after reaching the initial solid waste fee threshold. The permit recipient shall provide a copy of the building permit card for the project to the attendant at the designated site. No additional solid waste charges shall be charged until the tipping fee cost has surpassed the initial construction solid waste fee collected. Initial construction solid waste fees are part of the building permit application and are not refundable. The applicant for a building permit must provide an affidavit to the Building Official to certify that the solid waste (including construction waste and debris and woody wastes) from the permitted project will be appropriately disposed.

(b) Demolition.

Before a permit for demolition may be issued by the Building Official, the applicant shall provide an affidavit to the Building Official to certify that the solid waste (including construction waste and debris) from the permitted project will be appropriately disposed. Any solid waste from demolition shall be taken to a site designated by the Board of Supervisors and set forth with the demolition permit otherwise disposed of properly (i.e., recycled or reused where possible). Such demolition shall not be deposited into the solid waste receiving sites. Upon bringing such materials to the designated site(s), the applicant shall pay the rate set forth by the Board of Supervisors and said fee (price per ton) shall be noted on the demolition application and/or demolition permit. A demolition permit is required for any structure of 120 square feet or larger.

A demolition permit is required for any trailer, camper or barn that is being demolished and taken to the landfill. Demolition permits shall be subject to tipping fees as set forth in the preceding section. Tipping fees will be billed by invoice sent from County Administration.

(c) Brush Fee

Trees, branches, and brush shall be separated from the construction debris and shall be taken to the transfer station and charged at the rate set forth by the Board of Supervisors. All brush being taken to the transfer station by a business or commercial enterprise will be weighed at the scale and a ticket will be sent to County Administration for billing the responsible party. No stumps or branches larger than four inches in diameter are allowed in the brush pile. The price per ton is set annually starting on the date of inception and then transitioning to July 1st.

• Per ton price: \$70

(d) Tire Fee

Tires shall only be taken to the transfer station. Tires being brought in by a business or commercial enterprises shall be taken to the transfer station and charged at a rate set forth by the Board of Supervisors. Tires must be checked by the transfer station personnel and a ticket shall be created for billing by County Administration. Each household is allocated the disposal of eight passenger vehicle rated tires per fiscal year (July 1 to June 30). Households will be billed for any tires over their allotted amount. The price per tire is set annually starting on the date of inception and then transitioning to July 1st.

Per tire disposal fee: \$5

(e) Clean Fill

Appropriate clean fill shall be taken to the transfer station and charged at the rate set forth by the Board of Supervisors. All clean fill being taken to the transfer station will be weighed at the scale and a ticket will be sent to County Administration for billing the appropriate business or commercial enterprises. The price per ton is set annually starting on the date of inception and then transitioning to July 1st.

Per ton price: \$35

(f) Can Rental Compliance

Any person renting or owning a disposal can or container from a company for use to dispose of construction debris or other permitted waste shall be responsible for all tipping fees. Any refuse company renting cans for use in the County shall comply with this ordinance and will notify the County of all cans being rented in Bath County. The County will bill the renter of the can for the tipping fees after the initial solid waste fee paid for the building permit has been exceeded, or the cost of the tipping fees if a permit wasn't required.

Sec. 16-12. Repealed

ARTICLE VI. TRANSPORTATION OF SOLID WASTE CONTAINERS

Sec. 16-13. Transportation of solid waste containers.

Solid waste shall be hauled to and from the Transfer Station, Solid Waste and Recycling Receiving Sites, Designated Permitted Landfill, and other designated sites in containers with non-leaking, tight-fitting lids or containers secured in such a manner that materials cannot be strewn along the roads, streets or alleys of the County.

ARTICLE VII. ADDITIONAL SITES AND CONTAINERS

Sec. 16-14. Additional sites and containers.

The Board of Supervisors may from time to time designate other sites for residents for the purpose of receiving and disposing household solid waste and recyclable materials free from contaminants and may place containers for the collection of household solid waste and/or recyclable materials free from contaminants at these designated sites.

Sec. 16-15. Materials not to be accepted at designated sites.

Materials not accepted at the designated sites will include those items not accepted at a Solid Waste Recycling Receiving Site pursuant to Sec. 16-9.

Sec. 16-16. Repealed

ARTICLE VIII. USAGE OF TRANSFER STATION, SOLID WASTE AND RECYCLING RECEIVING SITES, AND OTHER DESIGNATED SITES

Sec. 16-17. Use of transfer station and sites.

- (a) The Transfer Station, Solid Waste and Recycling Receiving Sites, and other sites designated by the Board of Supervisors for receiving solid waste and/or recyclable materials free from contaminants shall be for the collection and disposal of solid waste and recyclable materials produced within the boundaries of Bath County.
- (b) No person shall be permitted to deposit solid waste at the Transfer Station or any Solid Waste and Recycling Receiving Site or any other site designated by the Board of Supervisors for receiving solid waste which has been transferred into Bath County from any other jurisdiction without obtaining special written permission from the County Solid Waste and Recycling Coordinator, or the Coordinator's duly authorized representative.

Sec. 16-18. Accepted materials at Transfer Station and other sites to be County property.

- (a) All materials delivered and deposited for disposal at the Transfer Station, a Solid Waste and Recycling Receiving Site, Designated Permitted Landfill, and/or additional designated site or container in accordance with the provisions of this Chapter shall become the property of the County and the County shall have the sole and absolute right and authority to dispose of the same. The County shall not become the owner of any materials delivered and deposited for disposal in violation of the provisions of this Chapter.
- (b) No person shall separate, collect, carry off, or dispose of materials delivered and deposited for disposal.

Sec. 16-19. County not liable for loss of valuables.

The County shall not be responsible for the loss of any valuables which may be inadvertently lost in any solid waste, but shall cooperate with the owner to the extent reasonably practical as determined by the County, to locate such valuables and restore same to the rightful owner. All articles of value which are found will be turned in and kept at the Bath County Sheriff's Office until claimed by owner.

ARTICLE IX. AUTHORITY OF BOARD TO PROVIDE FOR SOLID WASTE COLLECTION

Sec. 16-20. Board of Supervisors to provide for collection and regulations regarding solid waste.

The Bath County Board of Supervisors, through the County Administrator and/or other designated County employee(s) or agent(s), shall encourage and have the authority to approve the systematic collection of solid waste from public or private premises, and to provide and enforce proper regulations for the placement of the solid waste.

ARTICLE X. VIOLATIONS

Sec. 16-21. Violation of provisions; generally.

It shall be unlawful for any person to violate the provisions of this Chapter.

Sec. 16-22. Disposing of solid waste unlawfully.

It shall be unlawful for any person to dispose of any materials that are prohibited by this Chapter at the Transfer Station or at any Solid Waste and Recycling Receiving Sites or at any other site designated by the Board of Supervisors for receiving solid waste and/or recyclable materials free from contaminants.

Sec. 16-23. Tampering with containers, fences, equipment.

It shall be unlawful for any person to deface, remove, destroy or tamper with any materials, including fencing and collection containers for solid waste and/or recyclables and other equipment, buildings, structures, or any other property used in connection with the collection facilities at the Transfer Station or any Solid Waste and Recycling Receiving Site or at any other site designated by the Board of Supervisors for receiving solid waste and/or recyclable materials free from contaminants.

Sec. 16-24. Burning solid waste at transfer station, solid waste and recycling receiving sites, and other designated sites prohibited.

It shall be unlawful for any person to set fire to, or burn, any solid waste deposited at the Transfer Station or Solid Waste and Recycling Receiving Sites or any other site designated by the Board of Supervisors for receiving solid waste and/or recyclable materials free from contaminants without the written permission from the County Administrator.

Sec. 16-25. Littering.

- (a) Any person who dumps or otherwise disposes of trash, garbage, refuse, litter, or other unsightly matter, on public property, including a public highway, right-of-way, property adjacent to such highway or right-of-way, or on private property without the written consent of the owner thereof or his agent shall be guilty of littering.
- (b) When a violation of the provisions of this Section has been observed by any person, and the matter illegally dumped or disposed of has been ejected from a motor vehicle, the owner or operator of such motor vehicle shall be presumed to be the person ejecting such matter. However, such presumption shall be rebuttable by competent evidence.
- (c) The provisions of this Section shall apply to those agents employed by the County for the collection of solid waste, as well as to all other persons.
- (d) The provisions of this Section shall not apply to the lawful disposal of such matter at the Transfer Station or Solid Waste and Recycling Receiving Sites or at any other site designated by the Board of Supervisors for receiving solid waste and/or recyclable materials free from contaminants.

State law reference-Similar provision, Code of Virginia, § 33.2-802.

Sec. 16-26. Solid waste collectors to secure loads.

It shall be unlawful for any Solid Waste Collector to collect, pick up, transport, or dispose of solid waste or other waste material in the County unless such vehicle used for transportation of solid waste or other waste material is constructed or loaded so as to prevent any of its load from dropping, sifting, leaking or otherwise escaping therefrom.

Sec. 16-27. Open dumps unlawful.

- (a) It shall be unlawful for any person to own, establish, maintain, or operate an open dump for placement or deposit of any solid waste including but not limited to business, industrial waste, household solid waste, tires, white goods, inoperable vehicles or parts thereof, hazardous waste, infectious waste, construction debris, vegetative waste, or recyclable materials in the territorial boundaries of the County.
- (b) It shall be unlawful for any person to dispose of solid waste in open dumps or to allow solid waste or other waste to be disposed of on his or her property without a permit from the Virginia Department of Environmental Quality. Any person who removes trees, brush or other vegetation from land used for agricultural or forestal purposes shall not be required to obtain a permit if such material is deposited or placed on the same or other property of the same landowner from which such materials were cleared.

ARTICLE XI. PENALTIES AND ENFORCEMENT

Sec. 16-28. Criminal penalties.

Any person violating the provisions of this Chapter shall be guilty of a Class 1 misdemeanor and subject to a fine of up to \$2,500.00 and/or a term of imprisonment of up to 12 months in jail, and shall pay restitution for the costs of clean up. Each day that a person violates this Chapter shall constitute a separate offense and such violation shall, in addition, be subject to injunctive relief by a Court of competent jurisdiction within this Commonwealth.

Cross reference-Penalty for a Class 1 misdemeanor, § 1-14; State law reference – Va. Code §§ 33.2-802, 15.2-900, 10.1-1455(D).

Sec. 16-29. Civil penalties.

The cost of any clean up shall be charged to the person or persons violating this Chapter and may be collected in a separate civil action if not recovered in a criminal action under Section 16-28.

Sec. 16-30. Enforcement and prosecution.

- (a) The County Sheriff's Department shall be responsible for enforcement of the provisions of this Chapter.
- (b) The Commonwealth's Attorney and/or the County Attorney shall prosecute all violations of this Chapter.

ARTICLE XII. CHAPTER SUPERSEDES SOLID WASTE ORDINANCES

Sec. 16-31. Prior solid waste ordinances superseded.

This Solid Waste Chapter upon its effective date supersedes and repeals all solid waste ordinances previously enacted in Bath County.

Sec. 16-32. Effective date.

This Chapter shall become effective midnight May 14, 2024.

BACKGROUND: Application has been made for rezoning Tax Map #s 63B-1-46, 63B-1-47, 63B-1-48, 63B-1-49, which comprise an aggregate of approximately 2.237 acres. The property is located at 162 Roseloe Lane, Hot Springs, Virginia. The property is currently zoned R-2 Residential with a request to be rezoned to A-2 Agricultural General.

The purpose of rezoning is to have the ability to have livestock located upon the properties, which is not a permitted use in R2 Residential zoning.

The property currently has a single family dwelling. The adjoining properties are zoned R-2 Residential, B-1 Convenience Business, A-1 Agricultural Limited and A-2 Agricultural General.

Important factors to consider in making a rezoning determination include:

- (1) Has a need for rezoning been established?
- (2) Is the proposal consistent with the existing character of the community?
- (3) Will the rezoning promote orderly development of the community?
- (4) Will the rezoning adversely affect traffic flow or impede the normal flow of traffic?
- (5) Are there sufficient utilities available to support the proposed use (water/sewer/phone/electric)?
- (6) Will the rezoning adversely affect land values and/or the use and enjoyment of surrounding properties?
- (7) Will the rezoning constitute an illegal spot zoning?
- (8) Is the rezoning consistent with the County's overall land use development plan?

The proposed zoning would be a down zoning. The property is located within a designated growth area. The property is served by public water and sewer.

INFORMATION: The property is located within a designated growth area.

NOTE(S):

The Planning Commission held a public hearing on this matter on March 25, 2024. The Planning Commission voted 5-0 to recommend denial of the rezoning request to the Board of Supervisors based on comments made by the neighbors that were relevant to the factors to be considered for a rezoning.

Comments included:

- The rezoning would be out of character for the community i.e. pigs and goats that would be allowed on the property; Destroy the character of the development as it is strictly a residential area; It would devalue the area and the property values.
- Feeding the animals, as the property has been clear cut, would attract dangerous wildlife around the neighborhood, such as bears, etc.; The surrounding property values would be affected
- Neighbors bought their property due to deed restrictions that were in place and this property doesn't
 have all those restrictions but would impact all the other parcels.
- Animals could get loose and destroy lawns and personal property that folks have worked hard to keep up; Decrease neighboring property values; Agriculture in a subdivision is not appropriate.
- Agriculture in subdivision is not appropriate; Devaluation of properties in general.
- Everyone in the neighborhood keeps up their property and that property is already needing some attention; Object to the smell that would be created from the animals.
- As a neighboring business owner it could devalue properties, cause safety issues with patrons, increase
 bears and predators and smell would be an issue; Could cause a loss of business; Not the right place for
 this rezoning request.
- Downzoning isn't prudent for housing issue that currently exists within the county; This is a fence out county so all the neighbors would need to have fencing up to keep animals off of their property.
